When traveling **southbound** on I-95, take exit 261A.

When traveling **northbound** on I-95, take exit 261A

Then proceed east 2 miles on U.S. Highway 92 (International Speedway Blvd.) just past Daytona International Speedway.

From I-4, take Exit 129 onto U.S. 92 proceed east approximately 4 miles just past Daytona International Speedway.

NOTE:

If you took a state approved, 30-hour, laser training course between June 1, 2006 – May 31, 2008, those 30 hours will count towards your state renewal requirements of 20 hours.

2 of your required hours must be a state approved “Prevention of Medical Errors” class, and 2 of your required hours must be a state approved “HIV/AIDS” and “Bloodborne Pathogens” class. (1 hour must be HIV/AIDS)

These 4 required hours can be completed using home study, and can be obtained through any program that is approved for any profession that is regulated under the Dept. of Health. (that means that your cosmetology AIDS course will *not* count for electrolysis renewal).
